



ASSOCIATE MEMBERSHIP OF WINE INDUSTRY TASMANIA

To join Wine Industry Tasmania (WIT) as an associate member, you must be eligible under one of the six classes available: corporate, government, employee, student and network.

a Brand Showcase members (Corporate or Government) (\$598 per annum incl GST) are corporate or government members as listed below, who wish to upgrade their membership to showcase their company brand/ logo with a web site link, to the members resource section of WIT's exciting new web site to be launched in July 2008. This also includes access to Wine Industry Tasmania's resource section.

b Corporate members (\$447 per annum inc GST) are corporate entities or individuals who do not satisfy the criteria for ordinary membership but who have commercial or other interests in the wine industry, eg. wine distributors, wine writers, educators, grape or wine researchers, commercial suppliers to the industry, interested consumers etc. Where a member is a corporate entity, an individual person must be nominated as the formal representative of that entity. Additional employees, other than the nominated representative, may be nominated as employee members (see below).

c Government members (\$447 per annum incl GST) are government and semi-government departments or individuals with interests in the wine industry, eg TIAR, Primary Industries, Tourism, Economic Development etc. Where a member is a government department, an individual person must be nominated as the formal representative. Additional employees other than the nominated representative may be employee members (see below).

d Employee members (\$195.00 per annum incl GST) are individuals employed by ordinary members, corporate members or government members, which are corporate entities, in addition to the nominated representative of those members who would like to receive industry communications and information in their own right.

e Student members (\$131.00 per annum incl GST) are individuals who are currently studying a minimum of 50% of a full-time student equivalent load in a recognised Australian viticulture, oenology or other relevant course.

As an associate member, you will receive the following benefits:

- A permanent office and full-time executive officer to professionally represent the industry;
- A minimum of twelve full-colour industry newsletters per year via email;
- Invitations to a range of educational seminars and events, relevant to the industry;
- You will be given priority opportunities to exhibit your products/services at field days and other events;
- The opportunity to sponsor WIT member seminars;
- Access to the Wine Industry Tasmania logo for use in own marketing/corporate materials;
- While Associate members do not have voting rights, you are welcome attend and speak at general meetings.

The membership year is from 1 July to 30 June each year. Once you have joined as an associate member you will automatically receive a renewal in June each year.
